Executive Summary:

Northcoast Children's Services (NCS) operates both center base and home base programs across Humboldt and Del Norte counties which are primarily funded by the Office of Head Start, California Department of Education and the California Department of Social Services. Services are available for eligible families of children 0-5 years of age and pregnant women. NCS staff prepared this community needs assessment to meet the requirements of 1302.11 of the Head Start Performance Standards in preparation for our Base year Head Start and Early Head Start grant for the project period of August 1, 2023, through July 31, 2028. The information gathered is used to help design our program to meet the evolving needs of low-income families in our community.

Major Findings for our service area:

- High level of Adverse Childhood Experiences
- There has been an increase in access to transitional kindergarten for more fouryear old children
- There is an unmet need for center-based services for children under 3 years-of age
- The Fortuna and McKinleyville areas are the only communities in the service area with fewer subsidized slots than 3–5-year-old children in poverty
- There is a shortage of qualified teaching staff across the service area
- Poverty and risk of isolation are far higher than both the state and national levels across our service area

Overview of The Grantee

Northcoast Children's Services (NCS) was founded as a parent cooperative in the community of Manila in 1969 Today NCS provides services to pregnant women and children ages 0-5_and their families through both center and home based programs. The last several years of living through a pandemic have been difficult for both the community and the program. To this day we still have several open teaching positions and have been unable to open all our classrooms. In spite of these challenges NCS provided services to over 600 children and their families throughout Humboldt and Del Norte counties last year.

Methodology

Planning for the community needs assessment began during the 2021-22 program year. NCS management staff worked with the Board of Directors, Policy Council, staff and community members to identify the questions we wanted to answer beyond the minimum requirements outlined in the Head Start Act. Together we identified a wide variety of sources from which to gather internal and external data and solicit community involvement during the process. The data used is both quantitative and qualitative.

Some of examples of the data used are 2020 census data, county level birth rates, local childcare planning commission priority lists for childcare needs, expected TK enrollment projections and data from the resource and referral agency regarding hours and age of children for which parents are seeking care. Additionally, the group collaborated to design a community needs survey that was disseminated digitally and physically in English and Spanish.

General Area Description

Northcoast Children's Services service area spans two counties and 4,574 square miles on the Northwestern California coast. The Service Area borders Oregon to the North, the Pacific Ocean to the West, Mendocino County to the South with Trinity and Siskiyou counties to the East.

Humboldt and Del Norte counties have about 147 miles of Pacific coastline bordered by the rugged Coastal and Klamath Mountain Ranges. Home to the Coast Redwood, the area is densely forested. The area is home to six major rivers. Over 1,000 square miles of the two counties is protected or conserved and includes many national, state, county and local parks and recreation areas.

Governing Structure

Humboldt County holds 7 incorporated communities Arcata, Blue Lake, Eureka, Ferndale, Fortuna, Rio Dell and Trinidad. Del Norte County holds 1 incorporated Community, Crescent City. There are numerous unincorporated communities in both counties. Humboldt County's seat is Eureka and Del Norte's county seat is Crescent City. Humboldt County Association of Governments, a Joint Powers Agency comprised of the seven incorporated cities and the County of Humboldt, is the Regional Transportation Planning Agency for Humboldt County.

Eureka is home to the College of the Redwoods community college and Crescent City holds a satellite campus of the college. Arcata is home to Cal Poly Humboldt, a California State University campus.

Humboldt encompasses 31 separate school districts while Del Norte has one unified school district. Humboldt County has 82 public schools, 23 charter schools, and 3 private schools. Del Norte has 14 public schools, 4 private and 2 charter schools.

Humboldt and Del Norte Counties have eleven Indian reservations within its borders. Six Head Start AIAN grantees provide services to children in Humboldt and Del Norte.

Population & Related Trends

Population in the service area is growing at a much slower rate than the rest of the state and nation. The population of Del Norte County has shown a decline in the population while Humboldt County showed a slight increase. According to census data, between 2000 and 2010 the population in the service area grew by 9,208 persons, a change of 5.98%; Between 2010 and 2020, the population in the service area shrank by .60%; Del

Norte County saw a -3.03% decline and Humboldt County grew 1.37%. The state of California grew over 6% and the U.S. as a whole saw an increase of 7%.

Pelican Bay maximum security prison opened outside of Crescent City, Del Norte County in 1989. The prison has a capacity of 2,380 and housed 1,654 prisoners in 2022. This prison population is included in Crescent City demographics and results in increases in the male population and may skew the results of other Del Norte County demographic data.

Gender & Ages

The Service area has a higher than average population percentage rate of the age groups 55-64 and 64+ and lower rates of the age groups under 18. Humboldt County has a higher than average population percentage rates of the age group 18-24 likely due to the Community College and University. Del Norte County has lower female population, likely due to the prison male population. The higher percentages of the aging population are likely contributing to the slower than average population growth.



Racial & Ethnic Composition

In many ways, the north coast has much less racial diversity than the rest of California. Population by race within the service area is shown below. According to American Community Survey (ACS) 2017-2021 5-year population estimates, the white population comprised 75.13% of the report area, black population represented 1.56%, and other races combined were 5.45%. People identifying themselves as mixed race made up 9.75% of the population. The percentage of the population who identify as Native American in the service area at 4.68% is over five times higher than the both the state and the national levels. As a result, the tribal communities have a large influence on both the social and cultural values of the community as shown by the local efforts to revitalize both indigenous languages and traditions.

The Hispanic / Latino population of the service area is 13.06% and is significantly lower than the California and the national averages. The portion of the population in Del Norte County which is Hispanic is higher than that of Humboldt County. The service area is continuing to see growth in the Hispanic population as demonstrated by the 30% increase from the 2020 Census. There was a decline in the non-Hispanic population of 3.16%.

Services for the Hispanic population have increased in our communities in response to increasing community needs due to the population growth. An interagency collaboration, Latino Net, meets monthly with a mission to "improve the quality of life for Spanish- speaking families of the North Coast through networking, information, collaboration and advocacy". Paso a Paso, an organization funded through St Joseph Health, provides childbirth education, breast-feeding support, parenting classes and support groups. Paso a Paso educates and supports Spanish speaking pregnant women and their families through classes, home visits, hospital visits and connecting clients with the resources they need. While there is still a great need for interpreting


services, many community providers strive to meet the needs of the increasing Hispanic community by employing bilingual staff.

Foreign Born Population & Citizenship

The latest figures from the U.S. Census Bureau show that 10,599 people, or 6.44%, of the population in the service area are of foreign birth. This is less than the national average of 13.60% and state average of 26.5%. The report area has 5,245 non-Citizens, or 3.19%, in contrast to the state average of 12.31% and the national average of 6.58% non-Citizens living in the United States.


The unemployment rate of 3.4% in the service area is comparable to that of the State & the nation. The unemployment rate of Del Norte County is higher than that of Humboldt County.






Median Household Income

The median household income in the service area is significantly lower than the state or the nation. Nearly 50% of the service area has households with income under \$50,000 per year. Income levels in the service area are lower than state & national averages across race & ethnicities with the exception of Asian and 'some other race' households in Del Norte County. Per Capita Income (PCI), the average income earned per person in a given area, is \$29,980 which is \$7,657 less than the PCI of the nation and \$11,295 less than other areas of California. Del Norte County has a lower PCI than Humboldt County.



Children below Federal Poverty Guidelines





There are an estimated 1846 pregnant women annually in the service area with 554 living below Federal Poverty Guidelines (FPG). There are 4421 estimated children ages 0-3 in the service area with 1326 eligible children living under FPG. There are 2819 children ages 3-5 living in the service with an estimated 846 living under FPG. The communities with the highest numbers of eligible pregnant women and children are Eureka, Crescent City, Fortuna, Mckinleyville and Arcata.






Race and Ethnicity

In most cities, NCS serves more nonwhite families than the schools in the communities. The school district that serves the communities of Willow Creek & Orleans has a very high number of Native American students; these communities are close to 3 Native American reservations for the Yurok, Karuk, & Hoopa tribes. The community of Eureka has the highest numbers of Asian students in the service area. The communities of Fortuna, Crescent City, Eureka, and Redway have the highest numbers of Hispanic students. The Hispanic population of Humboldt County has seen a dramatic increase in the last 20 years. In turn, there has been an increase in the need for Bilingual services in Spanish. NCS average enrollment for children identifying as Hispanic ranges from 20 to 30% of total enrollment each year, rates higher than the general population.

Dual Language Learners & Languages Spoken

NCS serves higher numbers of Dual Language Learners (DLL) in our programs than are seen in local school districts. The primary language of the majority of DLL is Spanish. Additionally, there are smaller numbers of enrolled of Middle Eastern & Asian Language speakers. In the 21-22 year, 33% of NCS children were dual language learners with 24% primary Spanish Speakers, 2% primary Middle Eastern & South Asian Language Speakers & 6% Primary English speakers. The majority of DLL enrolled in NCS programs reside in Eureka, Fortuna, and Redway.

NCS has responded to this need, increasing the numbers of bilingual staff. The Fortuna area has seen a sharp increase in the number of English language learners enrolled in elementary schools. NCS currently operates with four bilingual home visitors as well as bilingual staff in classrooms, and will continue to monitor the needs of children who are dual language learners and their families.







Number of children with disabilities & types of disabilities

The disabled population on the North coast is significantly higher than the state averages with the Del Norte population being over two times the state average and Humboldt's over 1.5 times the state average. In the 21-22 school year, 14% of NCS children had an IEP and 12% had an IFSP. NCS employs Special Needs and Mental Health Coordinators to support parents and program staff help these children succeed in school. Additional services are provided by local school districts and special education services through the county offices of education. The majority of children with disabilities being served by the SELPA are those with speech and language impairments & autism. NCS has strong partnerships with the Local SELPA and RCRC to coordinate services for the children in NCS programs, which continue to strive to maximize positive outcomes for this population.


Education Needs of Eligible Families

Residents of Del Norte county complete high school and college degrees at lower rates than the state while residents of Humboldt county have higher rates of completing high school and college degrees. Hispanic / Latino residents of Del Norte do not complete high school at higher rates than the state while Hispanic / Latino residents of Humboldt complete high school at higher rates. 

Health Needs of Eligible Families



The service area is designated as having health, mental health, and dental professional shortages, with several areas designated as Medically Underserved Areas/Populations. Access to health services continues to decrease with the loss of pediatric clinics in recent years. This results in increasing challenges for families striving to maintain preventative health services for their children as required by Head Start and the public school system. The pandemic increased the difficulties in accessing care.

NCS employs a Health Coordinator to monitor children's health screenings, immunizations, and concerns as well as provide support to families and staff. Follow up is provided for staff and parent education, as well as safety planning for chronic health conditions such as asthma, anemia, lead poisoning, and vision and hearing difficulties.

Health Insurance

In the service area 7.30% of the population are without health insurance coverage. Residents of Del Norte county have lower rates of uninsured people than the state while Humboldt's rates of uninsured is slightly higher than the state.

Immunization Rates Among School Children

Immunization rates for children entering Kindergarten in Humboldt County are lower than the state while rates in Del Norte are higher. Humboldt also sees higher number of immunization exemptions than the State. Exemption rates for Humboldt county are higher than that of the state; data for exemptions in Del Norte county have been suppressed due to low numbers. Rates of exemptions have lowered since the legislation SB 277 which eliminated the personal belief exemption. Humboldt continues to have higher rates of children entering Kindergarten who have overdue immunizations or are enrolled conditionally while immunizations are obtained.

Oral Health

Dental health and the availability of dental health services are one of the top identified problems and needs for services by the community. Adults in the area report significant dental problems and problems accessing care. With the restoration of Denti-Cal benefits for adults, concerns have not decreased. Very few providers accept Denti-Cal leaving many families forced to drive over 100 miles to obtain care and treatment. Despite the identification of treatment needs, many children and families are unable access services so far away.

Mental Health

Mental Health of children and families remains a big concern on the North coast. The Covid 19 pandemic has exacerbated the concern. The service area consistently shows high Adverse Childhood Experiences (ACEs) scores and indicators of risk factors as well as associated health behaviors and health outcomes corroborate the concern. 6.4% of parents on the north coast that were surveyed in the 2021 California Health Interview Survey reported that mental health had a severe impact on their family in the past 12 months and an additional 4.9% reported that it had a moderate impact on their family. Mental health also impacts mortality rate in the north coast, deaths by suicide in the service area occur at more than twice the rate of the state.

The social emotional readiness of incoming kindergarteners is the top concern from Kindergarten teachers. NCS continues to serve high numbers of children who are not eligible for services under IDEA, yet have significant social emotional development concerns. NCS employs three Mental Health Coordinators to support staff, families and



Social emotional supports, as well as parenting education, are offered in each program to increase positive mental health outcomes for children. NCS staff works with families to identify concerns and link children and families with resources.


Hospitalizations for Mental Health Issues

Asthma

Exposure to Lead

Children in Humboldt county receive blood lead screenings at higher rates than the state but are less likely to receive the two screenings by 24 months as required by CHDP. Children in Del Norte county receive blood lead screenings at much lower rates

than that of the state Children under the age of 6 in Humboldt county test for elevated blood lead levels of 4.5 to 9.5 micrograms per deciliter at a rate 3 times that of the state and higher than any other county in the state. Rates of children with blood lead levels above 9.5 micrograms per deciliter occur at nearly twice the rate of the state. Data for Del Norte county were not available.

Other Prevalent Health Problems

Preventable health issues impact mortality rates of the service area significantly. The North coast has higher than average rates of deaths due to accidents and firearms. Deaths due to liver disease, chronic respiratory illness, and lung cancer occur at nearly twice the rate of the state. Deaths due to cerebrovascular disease in Humboldt county occur nearly three times the rate of the state. Deaths due to heart disease in Humboldt county are also higher than the state rates. Deaths due to diabetes in Del Norte county occur at twice the rate of the state. The service area has lower rates of residents living with HIV/Aids as compared to the state.

Perinatal health

The number of infants born with substance exposure on the Northcoast is staggering, with estimates from DHHS that one in four babies born in Humboldt County are prenatally exposed. The rate of substance use diagnosis for hospitalizations of pregnant females is 8% in Humboldt county as compared to 2% state wide. Humboldt and Del Norte infant mortality rates remain higher than the state. Also concerning are the rates of lack of prenatal care or late access to care on the Northcoast.

NCS serves 18-30 pregnant mothers each year through the EHS home based model. The Nurse Family partnership serves 132 new mothers through DHHS. NCS utilizes the Partners for a Healthy Baby evidence based curriculum. NCS employs a Health

Coordinator and Mental Health Coordinator to support services to families during the perinatal period. NCS partners with the Postpartum Mood Disorder Task Force and the Maternal Child Adolescent Health division of DHHS to increase community capacity for supporting families in the perinatal period.

Children Born to Addicted Mothers

Neonatal Abstinence Syndrome is a result of drug withdrawal from exposure in the womb. NAS is most often caused when a woman uses opiates during pregnancy. Humboldt County has a NAS rate of 13.5 per 1000 births while California has a NAS rate of 2.5 per 1000 births. No data is available for Del Norte County.



Nutrition Needs of Eligible Families

A high number of parents on the North coast report their children drinking significantly fewer sugar sweetened beverages and higher than average reports of children eating more than five fruits and vegetables a day. Coupled with that positive data are adult reports of much lower levels of physical inactivity than the state average. Public school students are still in the average range for being overweight or obese in Humboldt and higher than average in Del Norte.

NCS employs a Nutrition Coordinator and a Registered Dietician Consultant who work with field staff to screen and assess each enrolled child's nutritional status subsequently offering personalized information and support to staff and families with any nutritional needs and concerns.

Availability of low-cost food

Humboldt and Del Norte have slightly higher rates of Food Insecurity as compared to the state, however enrollment in the Free and Reduced School meal program is lower than the state average in Humboldt County. Children attending NCS center based programs are served two meals daily through the CACFP program. NCS parents report Cal Fresh enrollment at 52% and WIC enrollment at 61%. NCS supports families experiencing food insecurity through community referrals to resources, emergency food, information on low cost meals, and food budgeting.





Social Service Needs of Eligible Families

The North coast sees much higher numbers of child abuse reports as well as number of children in foster care, indicating higher rates of abuse. The Domestic Violence call for assistance and visits to the emergency room rates of Del Norte County are staggeringly high, over 10 times higher than the state as a whole. Identifying families experiencing these issues can be difficult due to lack of disclosure. NCS works to build trust and support families with family violence concerns. NCS employs Family Services Specialists to support staff and high risk families dealing with multiple stressors. NCS partners with DHHS, Family Resource Center Network, and Child Abuse Prevention Coordinating Council to increase community capacity for coping with these issues and continues to work towards strengthening community partnerships to address these concerns.

Social Vulnerability Index (SoVI)

The degree to which a community exhibits certain social conditions, including high poverty, low percentage of vehicle access, or crowded households, may affect that community's ability to prevent human suffering and financial loss in the event of disaster. These factors describe a community's social vulnerability. The social vulnerability index is a measure of the degree of social vulnerability in counties and neighborhoods across the United States, where a higher score indicates higher vulnerability. The service area has a social vulnerability index score of 0.80, which is which is greater than the state.

Area Deprivation Index



Rates or Property & Violent Crime

This indicator reports the rate of property crime offenses reported by law enforcement per 100,000 residents. Property crimes include burglary, larceny-theft, motor vehicle theft, and arson. This indicator is relevant because it assesses community safety.

In the sevice area, 5,022 property crimes occurred in 2014 and 2016. The property crime rate of 3,093.3 per 100,000 residents is higher than the statewide rate of 2,496.9 per 100,000. Rates of property crime in Humboldt county are much higher than the average rates of the state average while Del Norte have lower rates than the state average.



Violent crime includes homicide, rape, robbery, and aggravated assault.

Within the report area, the 2015-2017 three-year total of reported violent crimes was 2,500, which equates to an annual rate of 507.90 crimes per 100,000 people, higher than the statewide rate of 440.50. Del Norte's rates of violent crimes is significantly higher than the state average.

Rates of Drug and Alcohol Abuse

High mortality rates from drug overdoses as well as high misdemeanor and felony arrest rates are indicators that substance use is a community crisis. This is echoed in the results of the Community Needs Survey. Humboldt County has seen increased focus and efforts aimed to increase community capacity for prevention, intervention and treatment. The former transitional Housing unit, Multiple Assistance Center, has been transitioned into a primarily privately funded substance use inpatient center. There are increasing numbers of outpatient programs and support services through the DHHS behavioral health branch alcohol and other drugs services programs, as well as private for profit programs. The Child Abuse Prevention Coordinating Council has chosen Substance Use as a focus to reduce ACEs among our community's children. Identifying families dealing with substance use issues can be difficult due to the lack of disclosure. NCS works to build trust and support families with substance use concerns.

Alcohol Usage – Excessive Drinking

In the service area, 27,159, or 20.61% adults self-report excessive drinking in the last 30 days, which is greater than the state rate of 18.79%. Excessive drinking is defined as the percentage of the population who report at least one binge drinking episode involving five or more drinks for men and four or more for women over the past 30 days, or heavy drinking involving more than two drinks per day for men and more than one per day for women, over the same time period.

Drug Use

Drug Use in the service area continues at higher rates than the state. The north coast has seen a sharp increase of fentanyl use in the last five years. Amphetamines are also used at high rates in the area. Prescriptions for opioids are given at much higher rates than that of the state. Drug related deaths in the service area occur almost twice as frequently as the average rate of the state. There are very few substance use disorder programs available in the area, however Humboldt county has targeted efforts to increase services in the last few years.

Housing and Homelessness

Low housing affordability & high rates of homelessness were rated as the top two concerns and needs rated in the Community Needs Survey completed in 2018. Subsidized housing slots are very limited and affordability is low. While very little affordable housing has been added to the community in the last 5 years, there are several projects in process and housing elements are being updated. The Agency currently provides information and support to families expressing a need in this area through connection to resources and assistance with applications, including those for

subsidized housing complexes. NCS works with families to prevent families from losing their housing and assists families who are houseless to find homes. 56% of NCS families who were homeless during the 21-22 program year found stable permanent housing.

Housing Conditions


This indicator reports the number and percentage of owner- and renter-occupied housing units having at least one of the following conditions: 1) lacking complete plumbing facilities, 2) lacking complete kitchen facilities, 3) with 1 or more occupants per room, 4) selected monthly owner costs as a percentage of household income greater than 30%, and 5) gross rent as a percentage of household income greater than 30%. Selected conditions provide information in assessing the quality of the housing inventory and its occupants. This data is used to easily identify homes where the quality of living and housing can be considered substandard. Of the 63,260 total occupied housing units in the report area, 26,492 or 41.88% have one or more substandard conditions.

Cost-Burdened Households by Tenure, Total




HUD Assisted Housing

HUD assisted housing provides subsidies to reduce the financial burden of rent for low income renters. Del Norte County has more HUD assisted units available than the state average while Humboldt has fewer HUD assistance units. Communities throughout the north coast are updating their housing elements and focusing on increasing the availability of housing units and subsidized housing. Several new subsidized complexes have been built in the last five years. NCS family services staff work to connect families with affordable housing including application assistance for HUD assisted housing.

Transportation and Communication

The rural nature of the services area lends itself to infrastructure and transportation challenges. There are frequent road closures which prevent mobility throughout and out of the service area. Cell phone and internet services continue to be unavailable in some of the rural communities in the service area.

Transportation

There are higher rates of people walking and biking to school and work in the services area and lower number utilizing public transportation as compared to the state. Challenges to the provision of transportation to NCS sites include the number of program locations and distance between NCS sites. NCS does not provide bus services but does provide other transportation resources including raingear, strollers, and bus tickets as needed. NCS works with families to plan for transportation challenges. NCS also owns several vehicles to assist families in transportation to needed services such as medical and dental appointments as well as

socializations. NCS provides pedestrian and car seat safety education annually to enrolled families.



Child Care Availability

Child Development Centers, Child Care Centers, and Family Child Care Programs

There are 13 licensed child care facilities in Del Norte County and 55 in Humboldt county. 32% of Humboldt licensed facilities and 40% of Del Norte licensed facilities have state and/or federal funding. Additional subsidies are provided through the Parent Choice and Family Childcare Voucher programs offered through Changing Tides in Humboldt County. Services for children ages 3-5 have increased and are easily accessible through school district's Universal Transitional Kindergarten and Universal PreK programs. Additional services for preschool ages include First Five community playgroups, Special Services offered for developmentally delayed children through the office of education. Additional services for pregnancy to 3 include: First Five community playgroups; Special Services offered for developmentally delayed children through SELPA and RCRC; and Paso a Paso a program for Latino families. Additionally, Healthy Moms drug and alcohol recovery program offers free child care and parenting support.

Services for pregnant and parenting teens were cut several years ago and the need remains unmet. One center based program for parenting teen's remains in Del Norte County which has a very high rate of teen pregnancy. Supportive services for teen mother including those in the Humboldt High Schools remain unfunded.

Services for children with diagnosed developmental delay are comprehensive and easily accessed through the office of education and Regional Center programs. Special center based programs and transportation services are available for severely developmentally disabled and autistic children in Humboldt County. Services targeting the increasing numbers of autistic children have been increasing throughout the service area. HCOE has opened 2 centers serving children with special needs in Fortuna and Arcata. Additionally, Eureka city schools operates a center serving children with special needs located centrally in Eureka. NCS and the county offices of education continue to explore innovative ways to partner and serve children with diagnosed disabilities.



Approximate Number of Head Start-Eligible Children Served


There is an overall lack of services for ages 0-3 and in particular ages 2-3 as the Nurse Family Partnership program is only for 1st time mothers and ends at age 2. NCS Early Head Start Home Base Programs serve 198 children and families age birth to 3 through 81 center based slots and 117 home based slots. NCS operates 11 EHS centers in the service area serving primarily 2 year olds. College of the Redwoods operates an EHS center in partnership with the California Department of Education. There are also Tribal EHS Grantees in Eureka, Hoopa and Wietchpec. Cal Poly Humboldt offers a State funded infant toddler program that primarily serves students enrolled in the University.

There are 8 licensed centers serving Infants and Toddlers under the age of 2 in Humboldt and Del Norte Counties. Two of these programs are operated by NCS, two are operated by colleges. and Del Norte office of Education operates an infant toddler center for teen parents with an EHS childcare partnership at one of the high school campuses. The remaining 3 centers are private for profit centers. Additional EHS services are provided thorough Changing Tides which operates EHS Child Care Partnership in Family Child Care Homes. Nurse Family Partnership serves 150 children age birth to 2 for first time mothers in Humboldt.



There are few unserved eligible families in the 3-5 age group. With the increases TK and UPK, many communities have more 3-5 slots than eligible families. NCS serves 311 children ages 3-5 in center based Head Start programs and 31 in home based programs. NCS operates 15 Head Start classrooms and partners with an additional 2

centers to provide community enhanced services through Head Start. There are Tribal Head Start Grantees in the towns of Smith River, Crescent City, Klamath, Hoopa, and Eureka. There are 9 state preschools and child care programs in Humboldt County with a licensed capacity of 328 children. Del Norte Unified School District operates 4 state preschool programs with a capacity of 130 children. Several Humboldt school districts offer additional fee for service preschool services for age 3-5. Almost every elementary school is now offering Transitional Kindergarten programs, some with multiple classrooms. Approximately 231 children were enrolled in TK programs in Humboldt County in the 2020-21 school year.



Typical work, school, or training schedules

The majority of requests for child care are for traditional hours and full time care. This indicates that the vast majority of parents with eligible children have typical M-F work, school, & job training schedules. The majority of requests for child care are for children under the age of 5 with care requests for ages 2-5 slightly higher than that of under 2.




7. Are you interested in a home based program focused on learning activities for your child and assisting you and your family in accessing health and social services in your community?






8. Has the COVID pandemic impacted your ability or desire to access childcare?






9. Have concerns about COVID vaccine requirements impact your desire to send your child to preschool or childcare?






10. What barriers do you currently face in accessing preschool or childcare? Select all that apply








12. Please rate the availability of public transportation in your community.
