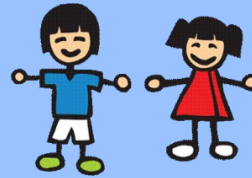

How much do services cost?

State funded Child Care Programs may have fees for services based on income.

How do I qualify for services?

Our Head Start and Early Head Start eligibility is based on income and age. Foster children, homeless families, and families with certain types of public assistance are also eligible.

How do I apply?

A paper or online application must be completed. You can apply for our programs at any time throughout the year.

Applications need to include a copy of immunizations for the child and proof of household income.
